VI. ORDINANCES AND RESOLUTIONS

15. City Attorney Rodak stated the Keno ordinance is changing the terms from a 1-year to 4-year term. To stagger the terms, two members will have a 2-year term and three members will have a 4-year term.

Council Member Rahmig introduced Ordinance No. 972, AN ORDINANCE AMENDING BRIDGEPORT CITY CODE §§ 32.10 WITH REGARD TO KENO DISTRIBUTIONS BOARD; PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT;

REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND TO PROVIDE FOR PUBLICATION OR POSTING AS REQUIRED BY LAW, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Wickard. Roll call resulted as follows: Aye: Rahmig, Wickard, Deines, Floyd; Nay: None. Motion carried. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Ordinance No. 972 was then read by title and thereafter. Council Rahmig moved final passage of the ordinance, which motion was seconded by Council Member Wickard. The Mayor then stated the question: "Shall Ordinance No. 972 be passed and adopted?" Roll call resulted as follows: Aye: Wickard, Deines, Rahmig, Floyd; Nay: None. Motion carried. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested to the passage and approval of the same and affixed her signature thereto.

Council Member Wickard made a motion to approve the Mayor's re-appointments of Lisa Weborg and Frank Catron to the Keno Board with a 2-year term expiring January 31, 2023, and Jeff Metz, Brad Huck and Hallie Sawyer to a 4-year term expiring January 2025, seconded by Council Member Rahmig.
