Council Member Wickard introduced Ordinance No. 971, AN ORDINANCE OF THE CITY OF BRIDGEPORT, NEBRASKA AUTHORIZING THE ISSUANCE, SALE, AND DELIVERY BY THE CITY OF ITS GENERAL OBLIGATION VARIOUS PURPOSE REFUNDING BONDS, SERIES 2021, IN THE AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$1,020,000; PRESCRIBING THE FORM AND CERTAIN DETAILS OF THE BONDS AND PROVIDING FOR THE FIXING AND ESTABLISHING OF OTHER DETAILS OF THE BONDS; PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL OF AND INTEREST ON THE BONDS AS THEY BECOME DUE; DESIGNATING THE BONDS AS QUALIFIED TAX EXEMPT OBLIGATIONS; ADOPTING CERTAIN POST-ISSUANCE TAX COMPLIANCE AND DISCLOSURE POLICIES AND PROCEDURES WITH RESPECT TO THE BONDS; AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH; AND PROVIDING FOR THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND TO PROVIDE FOR PUBLICATION OR POSTING AS REQUIRED BY LAW, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Oltmann. Roll call resulted as follows: Aye: Wickard, Rahmig, Deines Oltmann; Nay: None. Motion carried. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. RESOLUTION NO. 2020-15

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA AUTHORIZING THE EARLY REDEMPTION OF THE CITY'S GENERAL OBLIGATION VARIOUS PURPOSE REFUNDING BONDS, SERIES 2016, IN SUCH AMOUNTS AND IN SUCH MATURITIES, AS SHALL BE DETERMINED BY AN AUTHORIZED OFFICIAL OF THE CITY.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA AS FOLLOWS:

Section 1. The City of Bridgeport, Nebraska (the "City") has previously issued its General Obligation Various Purpose Refunding Bonds, Series 2016, dated March 15, 2016, in the original aggregate principal amount of \$1,525,000 (the "Series 2016 Bonds"), of which \$1,100,000 in aggregate principal amount is presently outstanding. The Series 2016 Bonds were authorized by an ordinance (the "Series 2016 Ordinance") duly passed and adopted by the Mayor and City Council of the City (the "Council") for the purpose of (i) refunding the City's Various Purpose Bonds (General Obligation), Series 2011, dated May 11, 2011 (the "Series 2011 Bonds"), and (ii) paying the costs of issuing the Series 2016 Bonds. The Series 2011 Bonds were authorized by an ordinance duly passed and adopted by the Council for the purpose of paying (i) the costs of constructing paving improvements in Street Improvement District No. 2009-1 of the City, and (ii) the costs of issuing the Series 2011 Bonds.

As set forth in the Series 2016 Ordinance, the Series 2016 Bonds maturing Section 2 on or after December 15, 2021 are subject to redemption at any time on or after March 15, 2021, as a whole or in part, at a redemption price equal to the principal amount of the Series 2016 Bonds called for redemption, plus accrued interest on such principal amount being redeemed to the date of redemption.

Subject to the conditions set forth herein, the Council hereby authorizes Section 3. the redemption of the following outstanding Series 2016 Bonds (the "Refunded Bonds"), and the payment of the redemption price of such bonds on March 15, 2021 (the "Redemption Date"), or such other date as shall be determined by the Mayor, Treasurer or Clerk of the City (each, including any person authorized to act on his or her behalf, an "Authorized Officer"), or each individually, all in accordance with the redemption provisions set forth in the Series 2016 Ordinance, after which date interest on such bonds shall cease:

The Series 2016 Bonds maturing on December 15, 2020 shall be paid at maturity. Any Authorized Officer may determine that one or more maturities of the Refunded Bonds listed above shall not be refunded and redeemed on the Redemption Date. Such determinations shall be set forth in a certificate of such Authorized Officer.

Section 4. On the Redemption Date, the principal of the Refunded Bonds, together with all accrued interest to but not including the Redemption Date, shall be paid upon presentation and surrender thereof at the corporate trust office of BOKF, National Association, Lincoln, Nebraska, as paying agent and registrar for the Refunded Bonds (the "Registrar").

Section 5. In accordance with the Series 2016 Ordinance:

- not later than 35 days prior to the Redemption Date (or such other date as may be acceptable to the Registrar), the Authorized Officers, or each individually, are hereby directed to file a copy of this Resolution with the Registrar; and
- upon receipt of this Resolution, the Registrar is hereby instructed to mail notice of the redemption of the Refunded Bonds to each registered owner thereof not less than 30 days prior to the Redemption Date (or such shorter period as may be acceptable to the then registered owners of the Refunded Bonds); and
- not later than 10 business days following its mailing of the redemption notice, the Registrar is further directed to file such redemption notice with the Municipal Securities Rulemaking Board and its EMMA portal.

Section 6. This Resolution shall be in full force and take effect from and after its passage as provided by law. The redemption of the Refunded Bonds authorized by this Resolution are subject to the prior issuance by the City of its General Obligation Various Purpose Refunding Bonds, Series 2021 (the "Refunding Bonds"). This Resolution shall have no force and effect if the Refunding Bonds are not issued within one year of the date hereof.

PWCC: Director Charlee Wallesen stated three new treadmills were ordered and will be here the following week; the racquet ball league has twelve members and the school has quoted \$1,000.00 for their equipment and labor to wax the floor; Cornhole league has six teams; Council Member Rahmig stated Gingerich will start the dirt work on the storage unit the following week; Wallesen stated a fogger machine was purchased to help with sanitizing in the workout area; Covid-19 has impacted room reservations.

Public Works: Director Lawrence Heinrich stated a company contacted the City inquiring the cost to be on city electricity and Council stated to go ahead and research the possibility; The city guys have been trimming trees in the electrical lines and have had an abundance of line locates. The city dump is now open for residents who reside in city limits. The staff found a 1-1/4-ton Ford Truck with self-contained sander and plow in St. Cloud, MN for \$37,000.00 and recommended the city send Perry Nelson and Dave Smith to look at it and purchase if it is in good condition.

Heinrich stated upon accepting the PWD position his request was to be provided a vehicle and discussed different options with Council. Council Member Wickard stated to pursue the State Bid Website and made a motion to authorize Heinrich with a spending budget up to \$25,000.00, seconded by Council Member Rahmig. Roll call resulted as follows; Aye: Rahmig, Wickard, Oltmann, Deines; Nay: None. Motion carried.

Administration: City Clerk Huck stated Laurie VanPatter with Municipal Supply updated the meter read system and stated the auditors will be here November 16th. Council Member Wickard gave an update on the nursing home, had a broken line from the boiler but the problem has been fixed.
