I. ROUTINE BUSINESS

The City Council of the City of Bridgeport, Nebraska, met in regular session at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 13th day of May 2021, beginning at 7:00 p.m.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor Charlie Browne called the meeting to order. Roll call resulted as follows: Present: Dean Rahmig, Will Deines, Mark Wickard; Absent: Jason Floyd.

Mayor Browne stated he found it unfair for a group of citizens to force additional cost on to a neighbor for something they do not agree with. Council member Deines stated the majority should rule. Ordinance No. 975 failed for a lack of a motion.

- 18. Mayor Browne, Council member Rahmig and Council member Deines discussed the Rural Fire Board Meeting concerning the possible addition of 4 bays to the Rural Fire building to house the City equipment in one location and hiring of a part-time Fire Chief. They agreed to go ahead to get some bids and blueprints. Council member Wickard expressed his concerns about having all the equipment on the south side of the railroad tracks. Council member Rahmig explained they now have options to take different routes and to contact the Sheriffs' office and the railroad when there are calls. Sheriff Cardenas stated most of the equipment has been housed on the south side of the tracks for some time.
