I. ROUTINE BUSINESS

The City Council of the City of Bridgeport, Nebraska, met in regular session at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 12th day of April 2018, beginning at 7:00 p.m.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor J.W. Berg called the meeting to order. Roll call resulted as follows: Present: Greg Lussetto, Charlie Browne, Dean Rahmig, Quentin Cranmore

Staff members present were: Utilities Superintendent Kautz & Street Superintendent Dave Smith, PWCC Director Betsy Mitchell, Utility Assistant Dan Smith

Mayor Berg presided and the City Clerk Huck recorded the proceedings.

Mayor Berg announced, "In accordance with Section 84-1412 of the Nebraska Revised Statutes, the open meetings act is posted at the back of the meeting room for the review of the public."

Notice of the meeting was given in advance thereof by publication in the Bridgeport News-Blade, the designated method of notice given, as shown by proof of publication, as shown by attached affidavit of posting.

Notice was given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and by email notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The Mayor asked if there were any letters of public correspondence for the board. There were none.

The Mayor asked if there are any visitors that would like to speak on an item that is not on the agenda. There were none.

Council Member Cranmore moved to approve the consent agenda as presented, seconded by Council Member Browne. Roll call resulted as follows; Aye: Cranmore, Rahmig, Browne, Lussetto; Nay: None. Motion carried.

IV. ORDINANCES AND RESOLUTIONS

11. City Attorney Rodak stated this ordinance would repeal the EMS Department and dissolve its entirety and will have an open discussion if it is introduced and if there is a second. Mayor Berg explained why this ordinance was introduced, he and others met with EMS Administrator Sarah Strawn who requested to have EMS Medical Director Dr. John Post removed and wanted a contract signed with a doctor from RWMC out of Scottsbluff. After separate discussions with Dr. Post and Robin Stuart from the Hospital and members of the Sheriff Dept he stated it was his decision to have this ordinance written up and presented.

Council Member Browne introduced Ordinance No. 935, AN ORDINANCE REPEALING ORDINANCE #799 AND CORRESPONDING BRIDGEPORT CITY CODE PROVISION 32.09; PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ORDERING THE PUBLICATION OF THE ORDIANCNE IN PAMPHLET FORM, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Lussetto.

Andy Jackson EMS Volunteer stated why make this decision so immediate and said there are people from the State of NE can come in and evaluate all areas including cost effectiveness and give their recommendation to Council and asked what the backup plan is if it fails.

Mayor Berg response was he looked at the problem and this is the best way to handle the situation, while Council Member Browne stated this has been going on well over a year.

Stephanie Murrell seconded what Andy stated about getting an outside entity. She asked Council to not waive the three readings to allow time to evaluate and take careful consideration before making any rash decisions.

Carrie Harless stated this was an issue that came up many times while serving on the Council for 8 years. She expressed her concerns with Sarah asking to replace Dr. Post as the Medical Director and finding a replacement for the position. She mentioned the City has limited funds available for the equipment upgrades while the hospital already has the equipment needed and if Dr. Post is not on staff then no volunteers can go out on calls.

Dr. John Post Medical Director stated for a long period of time the emergency ambulance system was strictly volunteer and didn't get paid. It changed from being a part of the Volunteer Fire Dept to a separate entity and during that time stipends were paid to Dr. Post and Sarah Strawn and a fee schedule was implemented for ambulance calls. He would like to see a different management tool instead of the City and be more streamlined into one system. He stated absolutely a plan is in place in which the management would be under the Hospital and any Bridgeport EMS personnel would like to continue being volunteers they would be vetted under the hospital policies and employee system then would start the volunteer rescue up again.

Andy Jackson asked if this has been on going problem for eight years why hasn't there been a solution. Council Member Lussetto responded saying the City did bring in an outside source in when the Fire and Rescue split, and Dr. Post stated they have brought in an outside source from the state several different times and the recommendation was to combine the BLS and ALS to one system.

Dave Smith stated last time there was an assessment by the State was in 2009 between the Fire and EMS Departments and there was not one with the BLS and ALS services. He stated the State can hire an independent group to evaluate and give their recommendations for the best way to develop a plan. He stated as a BLS group they are not against combining, they want an outside source to evaluate first and give their recommendations for what is best for the community.

Robin Stuart, Hospital Administrator reiterated what Dr. Post stated and wants the BLS personnel to come on board. She stated it would be easier for Dr. Post to have the units combined as one unit for him to sign off on both crews for the trainings and competencies that are required, and the end result is what is best for patient care.

Council Member Cranmore asked is there is a difference in price between ALS and BLS fee schedules. Robin Stuart stated there is a cost difference in fees but stated if ALS provides a BLS level of service they charge at the BLS rate. Mayor Berg visited with Randy Meiniger with Valley Ambulance out of Scottsbluff and stated if their crew provides a basic level of service that is what is charged as it is the law.

Michael Hunter asked is there a cost for an assessment to be done. Council Member Rahmig stated there is no cost.

Roll call resulted as follows: Aye: Brown, Lussetto; Nay: Cranmore, Rahmig. Motion tied, Aye: Mayor Jack Berg. The motion to suspend the rules was adopted by three-fourths of the Council

and the statutory rule was declared suspended for consideration of said ordinance. Ordinance No. 935 was then read by title and thereafter. Council Cranmore moved final passage of the ordinance, which motion was seconded by Council Member Lussetto. The Mayor then stated the question: "Shall Ordinance No. 935 be passed and adopted?" Roll call resulted as follows: Aye: Lussetto, Browne; Nay: Rahmig, Cranmore. Motion tied, Aye: Mayor Jack Berg. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested to the passage and approval of the same and affixed her signature thereto.

11. City Attorney Rodak stated this ordinance is to repeal only the breed specific sections and not the dangerous dog section. This is the first part of a two-part step process to make pet owners more accountable.

Council Member Lussetto introduced Ordinance No. 936, AN ORDINANCE REPEALING ORDINANCE #822 AND CORRESPONDING BRIDGEPORT CITY CODE PROVISIONS 90.60 THROUGH 90.64, AND SECTIONS (I), (J), AND (K) OR BRIDGEPORT CITY CODE PROVISION 90.99; PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Cranmore. Roll call resulted as follows: Aye: Cranmore, Browne, Rahmig, Lussetto; Nay: None. Motion carried. The motion to suspend the rules was adopted by threefourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Ordinance No. 936 was then read by title and thereafter. Council Lussetto moved final passage of the ordinance, which motion was seconded by Council Member Browne. The Mayor then stated the question: "Shall Ordinance No. 936 be passed and adopted?" Roll call resulted as follows: Aye: Lussetto, Cranmore, Browne, Rahmig; Nay: None. Motion carried. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested to the passage and approval of the same and affixed her signature thereto.

12. City Attorney Rodak explained this is a replat of two adjacent properties located in Northport which is within the 1-mile city jurisdiction of the city.

Council Member Cranmore introduced Ordinance No. 937, AN ORDINANCE OF THE CITY OF BRIDGEPORT NEBRASKA, ACCEPTING OF THE SUBDIVISION AND REPLAT OF THE PARCELS DESCRIBED IN EXHIBIT A, B AND C; PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR PUBLICATION OR POSTING AS REQUIRED BY LAW, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Rahmig. Roll call resulted as follows: Aye: Browne, Rahmig, Cranmore, Lussetto; Nay: None. Motion carried. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Ordinance No. 937 was then read by title and thereafter. Council Member Cranmore moved final passage of the ordinance, which motion was seconded by Council Member Browne. The Mayor then stated the question: "Shall Ordinance No. 937 be passed and adopted?" Roll call resulted as follows: Aye: Rahmig, Browne, Lussetto, Cranmore Nay: None. Motion carried. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested to the passage and approval of the same and affixed her signature thereto.

13. Council Member Lussetto introduced Resolution 2018-05, and moved that the resolution be adopted, seconded by Council Member Browne. Roll call resulted as follows: Aye: Browne, Rahmig, Cranmore, Lussetto; Nay: None. Resolution passed.

RESOLUTION NO. 2018-05

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA TO ACCEPT THE DUTIES AND REQUIREMENTS SET

OUT BY THE STATE OF NEBRASKA FOR THE USE OF HIGHWAY 385 FOR CAMP CLARK DAYS PARADE.

WHEREAS, the City of Bridgeport intends to create a parade route beginning at the intersection of 5th and Main Street to the intersection of 11th and Main Street for the Annual Camp Clark Days Event Parade on June 2, 2018 from 9:45 A.M. to 11:30 A.M., and

WHEREAS, closure of roadways along the parade route is necessary to relieve the through traffic from the area in the City of Bridgeport, Nebraska on or near the parade route, and provide a safe event for participants and spectators, and

WHEREAS, Main Street (US-385) roadway from 5th Street to 11th Street is part of the state highway system and is located within the official corporate limits or zoning jurisdiction of the City of Bridgeport, and

WHEREAS, the City of Bridgeport, while making use of the state highway system for a special event shall have the legal duty to protect the highway property from any damage that may occur arising out of the special event and the state shall not have any such duty during the time the City of Bridgeport is in control of the property as specified in the notice provided pursuant to LB 589/N.R.S §39-1359, and

WHEREAS, any existing statutory or common law duty of the state to protect the public from damage, injury, or death shall become the duty of the City of Bridgeport while making use of the state highway system for a special event and the state shall not have any such statutory or common law duty during the time the City of Bridgeport is in control of the property as specified in the notice provided pursuant to LB 589/N.R.S. §39-1359, and

WHEREAS, pursuant to LB 589/N.R.S. §39-1359, thirty (30) days advance written notice of the special event must be provided which specifies the date and time City of Bridgeport will assume control of the identified state highway property, as well as the date and time the City of Bridgeport will relinquish control of such state highway property to the State of Nebraska. In addition, the City of Bridgeport shall to provide beginning and ending locations for the highway closure including sufficient area for the placement of advance warning and/or detour signing, and include sufficient time for the City of Bridgeport to prepare and later clean the property prior to returning possession back to the State of Nebraska, and

WHEREAS, LB 589/N.R.S. §39-1359 dictates that if a special event includes any portion of the State of Nebraska Highway System, the City of Bridgeport shall, if a claim is made against the State of Nebraska, indemnify, defend, and hold harmless the State of Nebraska from all claims, demands, actions, damages, and liability, including reasonable attorney's fee, that may arise as a result of the special event; and

NOW, THEREFORE, BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, MORRILL COUNTY, NEBRASKA AS FOLLOWS:

Section 1: Said Parade Route and Road Closure referred to hereinabove is hereby adopted. The governing body of the City of Bridgeport acknowledges and accepts all duties set out in 589/N.R.S. §39-1359, subsection (2) and accepts that the City of Bridgeport shall indemnify, defend, and hold harmless the State of Nebraska from all claims, demands, actions, damages, and liability including reasonable attorney's fees, that may arise as a result of the event and such Parade Route and Road Closure is accepted by the City of Bridgeport and the Mayor and City Clerk are hereby authorized and directed to execute the same on behalf of the Municipality.

<u>Section 2</u>: <u>Repeal of Previous Resolutions</u>. Any other resolution or code section passed and approved prior to passage, approval, and publication or posting of this resolution and in conflict with its provisions is repealed.

<u>Section 3</u>: <u>Effective Date</u>. This Resolution shall take effect and be in full force from and after its passage and approval.

<u>Section 4: Severability</u>. If any portion or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such portion or provision shall not affect any of the remaining provisions of this Resolution, the intention being that the same are severable.
